- Table location requests cannot be guaranteed.
- All registrations have first come, first served.
- Please let us know if you require electricity for your booth.
- Use Lancer Circle to unload your product and then park in the west parking lot.

Terms and Conditions

1. Setup/Takedown:

- Setup begins at 10:00 a.m.
- o All tables must be set up by **NOON** and remain open until **4:00 p.m.**
- Cleanup must be completed by 6:00 p.m.
- If you do not arrive by 11:30 a.m., we will assume you have forfeited your table. It may be divided between neighboring vendors.
- Vendors must leave their area clean and trash-free.

2. Exhibitor Tables:

- Booths must be self-contained.
- Each booth includes an 8-foot table and one chair.
- o Nothing may be taped, tacked, or fastened to walls, ceilings, chandeliers, or floors.
- o If you prefer not to use the provided table/chair, indicate this on your application. **No fee adjustments** will be made.
- Special space needs should be noted on your application. We will try to accommodate.

Table assignments are final and cannot be changed on the day of the event.

3. Exhibitor Responsibility:

- MLHS is not responsible for accidents, occurrences, or acts of God.
- o Exhibitors are responsible for the conduct of their employees and representatives.

4. One Business Per Table:

- Only one business per table.
- Space may not be sublet or shared without prior approval.

5. Acceptance:

o MLHS reserves the right to decline any application if deemed in the best interest of the event.

6. Payment:

Full payment is a non-refundable registration fee due with submission of the agreement.

7. Electricity:

- Available on a limited, first come, first served basis.
- One electrical outlet will be provided per request.

8. **Wi-Fi:**

- o Public, unsecured wireless internet is available at no charge.
- o Requires acceptance of MLHS's terms of use.

9. Cancellation of Space:

- Application fees are non-refundable.
- o MLHS is not liable for weather, accident, health, or other causes preventing participation.

10. Cancellation of Event:

- o MLHS reserves the right to cancel the event due to venue issues, regulations, or acts of God.
- o Refunds will be issued for **vendor fees only**, not for loss of sales.
